This had been circulated to the Steering Group and Cllr Hogley confirmed that this would then be sent to the statutory consultees for the SEA process (Historic England, Environment Agency & Natural England and Kirklees / Peak District National Park). This consultation was not a public one and would last 5 weeks after which AECOM would start developing the SEA. The whole process will take several months
