1920 Neighbourhood Planning 11

Report from Cllr Hogley; Cllr Hogley has met with the Lady from ACOM who is doing the Strategic Environmental Assessment (SEA). She has done the Scoping Report and the SEA is due back to HVPC in June. The Council needs to publish the SEA , to improve the positives and address the negatives. The steering group consists of two parishioners and various community groups. During July and August the Report goes out for consultation and will be submitted to Kirklees Council in December. It then goes to the Planning inspector and if all is well it is put to a referendum of the parishioners in June 2020. There needs to be a 50% vote in favour for the Plan to become Policy. If this happens 25% of the Community Infrastructure Levy comes to the Parish Council for projects which ameliorate the effect of Development.
