1920 46 Public Bodies (Admission to Meetings) Act 1960 amended by the Openness of Local Government Bodies Regulations 2014 on 6 August 2014

1920 56 Neighbourhood Planning

Cllr Hogley updated members on the current consultation and asked them to encourage constituents to respond to the consultation. The public consultation period ends on the 15th September 2019. The leaflets have been distributed as widely as possible and have been placed in shops, libraries etc. Everyone is encouraged to familiarise themselves with the leaflet and the process by which members of the public can respond. Over the two month period for consultation anyone can complete the survey online (preferred) or on a paper copy.

Regulation 14 is also the opportunity for statutory bodies to respond and all relevant bodies have been contacted with details of the process and inviting their responses.

There is a separate email account for enquiries.

There will be ‘drop-in sessions’ at Honley in July and Holmfirth in early September where members of the public can discuss the process with members of the steering group and complete the survey.
