1920 61 Public Bodies (Admission to Meetings) Act 1960 amended by the Openness of Local Government Bodies Regulations 2014 on 6 August 2014

As Council meetings can be recorded, the Chairman checked if anyone wished to do so, to ensure reasonable facilities could be provided. No members of the public or press were present.

1920 62 Open Session at Planning

There were no members of the public present.

1920 63 To accept apologies for absence

1920 67 To confirm the Minutes of the Previous Meeting

RESOLVED: That the Minutes of the Planning Committee meeting held on 19 August 2019, numbered 1920/46 to 1920/57 were approved as a correct record.

1920 68 Completed Planning Lists

RESOLVED: That the completed Planning List 1920/04 dated 12 August 2019 be confirmed.

1920 69 Planning Applications – Kirklees Council

Members considered any new or amended applications received by Kirklees Council from 12 August to 03 September 2019 inclusive (List 1920/05).

RESOLVED: That the comments on the above applications be forwarded to Kirklees Council.

1920 70 Kirklees Council – Officers’ Decisions

RESOLVED: That the Decision Notices issued by Kirklees Council from 12 August 2019 to 03 September 2019 be noted. The Chairman pointed out that two corrections were needed. The Chairman said the Committee had disagreed with application 92178 – 7, Broomy Lea Lane, Netherthong. But on review of the decision letter, Kirklees Planning had said that they had received no comments from the Parish Council. On 92383 1, Bank End Knoll, Oakes Lane, Brockholes, the Chairman said the Council had commented on this application, but Kirklees Planning had said that no consultation was required.

1920 71 Neighbourhood Planning

Cllr Hogley reported that we were in the last days of the Regulation 14 Consultation. It finishes on 15 September 2019. She encouraged those present to express their views if they had not already done so and to encourage others to do so. Cllr Hogley reported that they had had a successful two days consulting with members of the public through drop-in sessions at Holmfirth Library. Around thirty-five people had engaged. It was noted that some members of the team are visiting local community groups to engage directly with them.

1920 72 Planning Matters

RESOLVED: BT proposed to remove public payphone in Brockholes (New Mill Rd HD9 7AE) and New Mill (Penistone Rd HD9 7JL). Neither was a “traditional” red phone box; both were

modern, glass phone boxes. One had had no use in the past year, and one had only been used once. The Committee voted not to fight the removal nor to adopt the boxes. The Committee agreed that we should reply back to BT and request them to leave the site tidy after the removal.
