- The property would be a low-carbon, triple-glazed, air-sourced heat pump, grey water harvesting, highly insulated property.
- That similar properties had had similar applications approved."

  - The Planning Committee has one budget line under its remit. This is 4505 Neighbourhood Plan. At the start of the Council year, the budget contains £1,500. No expenditure has come from this budget line.
  - It is projected that money may be spent from this fund on the art and design on the Shop Front Design Guide Booklet. A quote for artwork, art direction and layout design has been received for £1,120.00.
  - The Booklet will be an 8-page, full colour A5 saddle and stitch booklet on 150gsm silk finish paper.
  - Subsequent printing costs will depend on the print run:

x250: £118.30
 x500: £153.90
 x1000: £213.98
 x1500: £279.22.

If this money was not spent this year, the money could be rolled over into an earmarked reserve under regulation of the HVPC Financial Regulations as this is an ongoing project.

# 2425 128 Traffic Calming

# i. Purchase and placement of SIDs for the Holme Valley

At the full Council meeting on 27th March 2023 councillors approved the expenditure of up to £5,000 on a mobile speed indicator device (SID). This SID is now active within the scheme for Holme Valley South on Penistone Road. At a meeting of the planning committee on 5 February 2024 Cllrs resolved that the clerking team would progress the purchase of a second SID for the Holme Valley. The second SID is now in place on Station Road in Honley close to the High School. The Assistant Clerk will be following with a news piece about the school campaigners. The Parish Council is still to be invoiced for either SIDs.

Members also commented on data collection sheets for two speed camera placements from Kirklees Highways supplied by Kirklees Cllr Mo Crook (not part of the supporting documentation):

- Dunford Road November 2023 to January 2024
- Greenfield Road February to April 2024

The Dunford Road data was not concerning. However, Members noted that 42.4% of vehicles on Greenfield Road exceeded the speed limit and 19.2% were travelling above the enforceable limit, - that is over 35 mph in a 30. This would be above the threshold for a speed camera van. The Committee considered any further action.

Resolved: The Committee resolved -

- To ask Cllr Crook and other district Councillors to share data from speed indicator devices in the Holme Valley.
- To ask Cllr Crook if a subsequent positioning of a speed camera van from West Yorkshire Camera Safety Partnership on Greenfield Road was an outcome of the Greenfield Road SID data regarding 19.2% of vehicles being over the enforceable limit. The Greenfield Road SID is close to a primary school.

# ii. School Parking Bollards

The Assistant Clerk on 13 May 2024 ordered a set of six "Think Before You Park" bollards, for Brockholes School. The cost was £474 plus £94.80 VAT (which the Parish Council reclaims) totalling £568.80. An email was received from Brockholes school on 19 July 2024 confirming that they had received the bollards but did not wish to use them, the bollards have now been collected and are in storage. At a previous meeting of this committee on 12 August 2024 Cllrs were actioned to approach primary schools they have a connection to, to find the bollards a new host school.

The Committee considered any further action.

**Resolved:** Cllr Liles would, in the first instance, contact Hade Edge School. Another option might thereafter be Holmfirth Junior and Infants School.

# Kirklees Council (Traffic Regulation) (No. 02) Order 2024

We support this proposed Traffic Regulation Order (TRO) *in principle*, but object to the proposal for permissive use by some recreational motorists and to the lack of consultation regarding Ramsden Road and connecting routes. We therefore object to elements of the first schedule and to the references to permits in the proposed order and the statement of reasons. Our response groups the roads into through routes, because our points differ for each of these routes.

# Ramsden Road, Holme Woods Lane, Kiln bent Road, Rake Head Road & Old Gate

- You indicate in the current draft TRO that it will not apply to motor vehicles which display a permit issued by you. But, unlike the 2021 PSPO, you have not specified what the conditions for issuing permits will be. We think, to meet the issues identified by the 2007 petition, by you in the 2009 report to Cabinet, by PDNPA, and to fulfil the statutory purposes (avoiding danger, preventing damage, facilitating the passage of non-motorised traffic, preserving the character of a road especially suitable for walking and horse-riding) given in your statement of reasons, you should only issue permits for use as indicated in paragraphs 2.2.1, 2.2.2 and 2.3 of the draft TRO and for use by people requiring access to land accessed from the route, i.e. all recreational motor vehicles (cars, quad bikes and motorcycles) should be prohibited.
- It seems to us that imposing a permit TRO for motorised access to these lanes (other than Old Gate) would inconvenience owners and occupiers of land and other premises adjoining the route, and their visitors.
- Consultation; once again it seems that this has been particularly poor for this area. A recent FOI request revealed that no-one has actually been consulted on the proposed TRO meaning that residents, landowners (and their tenants) or Holme Valley Parish Council have not had an opportunity to shape the proposal. One resident in particular would effectively be "locked in" behind gates / barriers without any explanation how such a system would operate.
- Gates / Barriers; these were installed in February 2023 for the then proposed PSPO. Again
  these were positioned without any consultation and it was quickly recognised by residents
  and landowners that at least two of the four were inappropriately located and would lead to
  unnecessary inconvenience if they were ever to be put into operation. These gate form part of
  the proposed TRO and therefore are unacceptable.

# Cheese Gate Nab Side, Scar End Lane and Scaly Gate

These three unsealed unclassified roads are outside PDNPA, but close enough to the routes described above to form part of the circuits popular with recreational motor vehicle users of green lanes. In the 19<sup>th</sup> century they were well-maintained for horse-drawn vehicles, but were not (or only partially) sealed with tarmac in the 20<sup>th</sup> century because there are alternative tarmac roads in their vicinity which provide access between the A616 and the top of the steep hillside to the northeast. Use by recreational motor vehicles (motorbikes and 4x4s) has led to significant damage and nuisance for local residents and other non-motorised users of these routes.

However the TRO as drafted does not cover the western end of Scaly Gate or the southern end of Scar End Lane, the sections of these roads where recreational motorists (mainly motorcyclists) access unenclosed moorland. We think you should include these sections of the roads in the TRO, i.e. the 85 metres of Scar End Lane between its junction with Scar Hole Lane and the proposed barrier location (closure point on Plan 5), and the section of Scaly Gate between the proposed eastern barrier location (closure point on Plan 5) and its junction with Hirst Lane, Intake Lane and Scar End Lane. If you do not include these sections in the TRO, the motor vehicle damage to these unenclosed areas will continue. There will also be problems from recreational motorists driving on these two narrow sections and then having to turn round when they get to the barriers. We do not ask that you change the barrier locations, as we understand local residents and businesses have been consulted on these (unlike the Yateholme area), merely that you extend the lengths of road covered by the TRO to allow you to put up TRO traffic signs at the southern end of Scar End Lane and the eastern end of Scaly Gate.




# Description of highway to be stopped up

# **Subject Matter**

The Places for Everyone Plan (PfE Plan) is a joint development plan document of nine Greater Manchester authorities (Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, Trafford, and Wigan) which was adopted on 21st March 2024.

The PfE Plan sets out a clear spatial strategy for delivering new homes and businesses along with infrastructure to support development and to protect and enhance our towns, cities and landscapes. It covers a timeframe up to 2039.

The draft SPD supplements PfE Policy JP-C8 - Transport Requirements of New Development, in particular clause 17. This clause requires planning applications accompanied by a Transport Assessment to consider air quality impacts on Holcroft Moss, which is within the Manchester Mosses Special Area of Conservation (SAC), to ensure new development does not have an adverse impact on its protected habitats and species.

The purpose of this SPD is to:

- Ensure that advice is consistent with the latest Government regulations and associated Planning Practice Guidance;
- Ensure that new development is consistent with the provisions of the recently adopted PfE Plan;
- Provide a robust basis upon which the nine PfE authorities can secure contributions from developers to ensure that the impacts of schemes on Holcroft Moss are appropriately mitigated; and
- Provide clear advice to developers as to what is expected in applications to ensure an efficient process for consultation and determination.

Views are sought on the Draft Holcroft Moss Planning Obligations SPD and its supporting documents.
